 5. Loading Pad: 50 mm x 50 mm steel surface



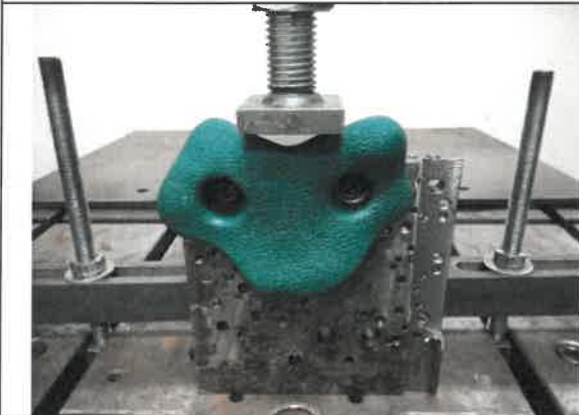


Photo C : Test setup

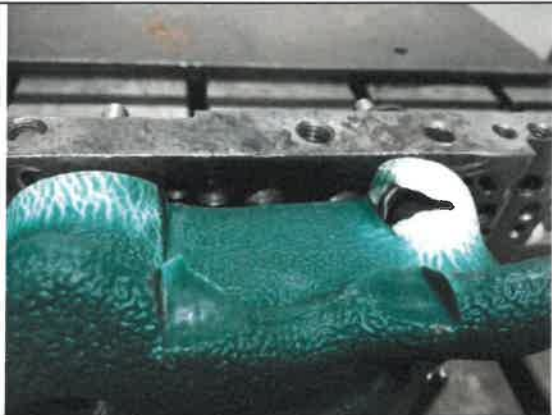
