Even though we strictly sell to retailers or other manufacturers - we will send our products directly to your customers for you; we call these types of orders "Drop Shipments". For dropship orders, there is a \$4 charge for each order. There is a \$2 charge for orders under \$25. We do not ship any dropship orders with any of our information on any of the labels or paperwork. Any information on the box or associated paperwork will have your business' name on it. Generally speaking, orders will ship within 48 hours of when it was placed. Summer months may be a bit longer.

We ship USPS, UPS and LTL. We have excellent discounts set up with both UPS and the trucking lines, and we pass all discounts on to our customers.

Returns: If a product is damaged upon receipt, it needs to be noted when it is signed for. We will then send a call tag and file a claim.

Tracking Information: Tracking information can be located on each invoice, as well as in an email that is sent to you.

Invoices: All Invoices are e-mailed the same day they are printed.

Our terms for customers that have a line of credit with us are: 2/10 Net 30. That is a 2% discount on payments made within 10 days, full payment expected within 30 days. For customers that do not have a line of credit, we will have your credit card information on file and use it when sending each order. After the card is used, we will send a copy of the receipt.
